11-2025/26 MINUTES OF THE PREVIOUS MEETING

Cllr Alex Lightfoot proposed an amendment to minute 7(1)-2025/2026; the resolution should read an alternative solution rather than above ground in the Spring of 2026. A further amendment removing Cllr Boyd from the attendees as he had not been present.

12-2025/26 MONTHLY ACCOUNTS

1. To approve the Payments and Receipts lists as presented for July 2025

The committee were advised a saving had been made against the Beach Litter budget line due to the alternative arrangements being trialled this summer. A long-term solution was also being explored. A saving had also been made in relation to the Beach Safety Service as no inflationary increase. The Expenditure against budget through 31 July 2025 was then noted.

The Committee considered the confidential paper detailing the Council's contracts. Members discussed various contracts and explored potential areas where savings could be made in the future including where economies of scale could be secured through joint working or bringing works in-house. The new staffing structure would need to be in before any significant changes could be explored.
